SOUTH PYMATUNING TOWNSHIP REGULAR MEETING

The Regular Meeting of the South Pymatuning Township Board of Supervisors was held July 10, 2013 at 6:00 PM in the Municipal Building with Chairman Brian Geisel, Supervisors Mark Presley and Roy Masotto, and Secretary R. Glenn Adams in attendance. Solicitor Robert Tesone was absent.

The meeting was opened with the Pledge to the Flag.

Brian announced that an Executive Session was held on July 1, 2013 at 4:00 PM to discuss personnel matters.

A motion was made by Brian Geisel and seconded by Mark Presley to approve the minutes of the June 12, 2013 Regular Meeting and to dispense with the reading of them. Motion passed unanimously.

Bob Bell from Penn DOT spoke about the Route 18 causeway repairs scheduled to begin April 2014.

Visitor Comments:

Evelyn Klein thanked the police department for their response after a robbery at her home.

Dennis Sump would like Big Tuna's to install a fence around the business and he has already spoken with the zoning officer regarding this. Mr. Sump asked what roads would be seal-coated. Mark mentioned a couple of roads to be seal-coated and said the township does not have to pay for it this year. Mr. Sump then asked about a grass cutting ordinance.

Police, fire, and zoning reports were read.

Glenn Adams read a letter from a housing rehabilitation recipient thanking Waltz Consultants and Rupp Construction.

A motion was made by Brian Geisel and seconded by Roy Masotto to pay the bills totaling \$78,201.57. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Roy Masotto to adopt a Resolution providing for supplemental appropriations for the 2013 Budget. Impact fee revenues in the amount of \$533.76 were received from the state. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Mark Presley to hire Ben Shaffer as a part-time patrolman. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Mark Presley to adjourn the meeting. Motion passed unanimously. Meeting adjourned at 6:25 PM.
