**South Pymatuning Township Regular Meeting**

**The Regular Meeting of South Pymatuning Township Board of Supervisors was held December 12, 2018 at 6:30PM in the municipal building with Chairperson Bill Klumph, Supervisor's Chuck Vranich , Rose Lyons and Charlie Steele solicitor.**

**The meeting was opened with the pledge to the flag.**

**It was announced that Executive Sessions were held on November 20<sup>th</sup>, November 28<sup>th</sup> and December 05, 2018 to discuss personnel issues.**

**Fire Reports were read.**

**A motion was made by Bill Klumph and seconded by Rose Lyons to approve the minutes of the Regular meeting held November 14<sup>th</sup> and the Recessed meeting held November 27<sup>th</sup>, 2018. Motion passed unanimously.**

**A motion was made by Bill Klumph and seconded by Rose Lyons to approve the bills in the amount of \$60,453.78 and payroll total of \$24,416.88. Motion passed unanimously.**

**A motion was made by Bill Klumph and seconded by Rose Lyons to adopt the Cable TV Municipal Agreement. Motion passed unanimously.**

**A motion was made by Bill Klumph and seconded by Rose Lyons to hire Bobbie Russell as Township Office Worker effective December 03, 2018. Motion passed unanimously.**

**A motion was made by Bill Klumph and seconded by Chuck Vranich that the township abandons broken or unusable tools and misc property. Motion passed unanimously. Toth asked what kind of items and how many were disposed of.**

**Public Comment:**

**Dennis Sump asked about the circles on the floor downstairs in the garage area. Klumph said there were a few leaks he is contacting the contractor. Sump asked about the contract negotiations. He asked who sits on the board and Steele said all supervisors are invited and involved.**

**Kurt Toth said he texted Lyons about the LED light out. Toth said there is a sign that is rusted out on Buckeye Dr. Toth congratulated Vranich on his appointment. He asked Vranich what his resume was and Toth said he will be happy to spell his resume out. Toth said he is 3<sup>rd</sup> generation and has been coming to meetings for over 20 yrs., took a bullet for the township, has been in 2 unions and runs a successful business. Toth said Lyons stated on the street that she didn't want to work with him so that's why she chose Vranich. Toth said there was a bash meeting at the FD dept. about Bill Klumph. Toth said Lyons and Vranich are in together. He told Klumph he was the only who stood up for him. Vranich asked Toth regarding the meetings he is referring to what his position was. Toth said he heard on the street that Lyons made a comment that the road crew formed an opinion of him and that's the reason why she didn't want him as supervisor. Lyons said there was 3 applicants and said at the meeting she stated she could work with Toth and Vranich. Vranich asked Toth if he would do the audience a favor and relate the purpose of what he is doing here and what he is saying. Vranich said Toth is upset because he is not sitting on the board.
