

South Pymatuning Township Regular Meeting

The Regular Meeting of the South Pymatuning Township Board of Supervisors was opened at 6:00 p.m. with Supervisors Matthew Chalupka, Chairman, Michael Anglin and Solicitor James Nevant present. Supervisor, Johnathan Leyshon, attended via telephone. Prior to the meeting, the Colt Road improvement bids were opened. Solicitor Nevant responded all bids were received on time, by responsible bidders and all were in order.

There were eight residents present.

A motion was made by Chairman, Matthew Chalupka, and seconded by Supervisor, Michael Anglin to dispense with the reading and approve the minutes of the June 11, 2025 Regular Meeting. The motion was unanimously approved.

Supervisor Chairman, Matthew Chalupka, announced the continuance of seal coating on Buckeye Drive and Downing Lane would start tomorrow (July 10, 2025) and the bids for Colt Road improvements had been opened and Frank Martuccio Asphalt and Paving, Inc. was the lowest bidder.

The Police Department report was given by Michael Anglin, Supervisor and the Fire Department Report was given by Michael Kilcoyne, Fire Chief.

Matthew Chalupka, Supervisor Chairman, announced the following approved building permit for: Aaron VanZanten, 4728 Tamarack Drive-above ground swimming pool.

A motion to pay the bills totaling \$52,572.61 and the June payrolls totaling \$39,374.37 was made by Chairman, Matthew Chalupka and seconded by Supervisor Michael Anglin. The motion was passed unanimously.

There was no correspondence or old business.

A motion by Matthew Chalupka, Chairman, and seconded by Michael Anglin to approve the Allan Rummel Sewage System Maintenance Agreement. The motion was passed unanimously.

Matthew Chalupka, Supervisor Chairman, made a motion to approve Frank Martuccio Asphalt & Paving, Inc. as the lowest bidder for the Colt and Townline Road improvements. Martuccio's bid was \$75,822.80. The motion was seconded by Supervisor, Johnathan Leyshon, and was passed unanimously.

Residents, Jan and Sam Heaslip, 246 Hartford Road, offered comments and expressed concerns of the proposed Pivot Solar Project construction. Supervisor, Matthew Chalupka, stated the project application had been denied and if appeals were made by Pivot, the Heaslips would be notified.

Resident, Yvonne Robison, asked if it was her responsibility to mow the Buckeye Drive side ditch of her property. The Supervisors will review that area for maintenance.

Resident, Dan Sump, commented on the condition of Buckeye Drive since PennDOT had seal coated it.

The meeting was adjourned at 6:36 p.m.
