

South Pymatuning Township Regular Meeting

The Regular Meeting of the South Pymatuning Township Board of Supervisors was opened at 6:00 p.m. with Supervisors Matthew Chalupka, Chairman, Johnathan Leyshon and Michael Anglin and Solicitor James Nevant present.

The meeting was opened with the pledge to the flag.

There were four residents present.

A motion was made by Chairman, Matthew Chalupka, and seconded by Supervisor, Johnathan Leyshon to dispense with the reading and approve the minutes of the November 12, 2025 Regular Meeting. The motion was unanimously approved.

Supervisor Chairman, Matthew Chalupka, announced the 2026 budget was complete and available for public review with adoption to occur on December 30, 2025.

Kurt Toth, resident, asked why the motion to purchase GPS. Chairman. Chalupka, commented it's for accountability.

The Police Department report was given by Johnathan Leyshon, Supervisor and the Fire Department Report was given by Yvonne Robison.

Matthew Chalupka, Supervisor Chairman, announced the following approved building permits: Hodge, 3175 Maplewood Drive-fence and Brannon, 6572 Seneca Road-horse barn.

A motion to pay the bills totaling \$45,415.93 and the November payrolls totaling \$77,696.98 was made by Chairman, Matthew Chalupka and seconded by Supervisor Michael Anglin. The motion was passed unanimously.

There was no correspondence or old business.

A motion by Supervisor Chairman, Matthew Chalupka, to hire Heidi Marshall to provide grant writing services for miscellaneous Township projects effective immediately, contingent upon developing acceptable terms and conditions of compensation. The motion was seconded by Johnathan Leyshon, Supervisor and was passed unanimously.

Matthew Chalupka, Supervisor Chairman, made a motion to adopt Resolution No. 10-2025, retroactive to December 3, 2025, on behalf of the Sharpsville Inclusive Play and Accessibility Fund, hereby requests a Local Share Grant of \$400,000.00 from the Commonwealth Financing Authority for the development of an Inclusive Playground. Johnathan Leyshon. Supervisor, seconded the motion and it was unanimously approved.

A motion to purchase GPS units for Township vehicles at a cost of \$80.00 per unit and \$24.00 per unit monthly airtime was made by Chairman, Matthew Chalupka, seconded be Johnathan Leyshon, Supervisor and passed unanimously.

It was announced the Township would be researching the cost of a new police cruiser.

Resident, Kurt Toth, asked to be considered to serve in the capacity of Vacancy Board for 2026.

Robert Germano, Tamarack Drive resident, expressed his concerns about vicious dogs, the catch basin across from his residence, the zoning ordinance relating to construction of fences, location of utility poles and the ditch at the intersection of Saranac and Tamarack Drives.

A resident asked if fog lines could be painted on Buckeye Drive, Chalupka will look into having it done.

The meeting was adjourned at 6:30 p.m.
